



2019 CERTIFIED MEDICATION AIDE 8-HOUR UPDATE

A Certified Medication Aide shall renew certification every twelve (12) months. Recertification requires documentation of completion of at least eight (8) hours of continuing education every twelve (12) months, excluding the first year, after certification as a medication aide. In addition, certification as a Long Term Care Aide, Home Health Aide or Developmentally Disabled Direct Care Aide must be current.

Care Providers Oklahoma is sponsoring continuing education programs for 2019, approved by the Oklahoma State Department of Health, which will provide the required 8 hours necessary to renew the certification of CMA's.
