## **Utilizing QAPI for building an effective pressure injury program** (#W29)

### **Course Description:**

An in-house acquired or declining pressure injury puts providers at risk for regulatory citations and litigation. The burden on the provider is to demonstrate that the development or decline of a pressure injury was unavoidable. The interventions that are implemented within the first 24 hours are critical, as well as on-going interdisciplinary updates to the plan of care. This session will utilize the QAPI approach for implementing or enhancing a pressure injury program to ensure your pressure injury program meets regulatory guidance for F686, as well as NPUAP and WOCN standards of practice to minimize regulatory and legal risk.

### **Course Objectives:**

1. Develop an interdisciplinary team approach and have effective team meetings that include prevention
2. Demonstrate how to effectively utilize the wound care nurse to manage and oversee the program
3. Review common assessment, documentation and program errors that put facilities at risk for litigation or regulatory citations

### **Course Description:**

An in-house acquired or declining pressure injury puts providers at risk for regulatory citations and litigation. The burden on the provider is to demonstrate that the development or decline of a pressure injury was unavoidable. An effective care plan is based on identification of the individual risk factors and implementation of interventions will help mitigate risk of pressure injury development. This course will provide a hands-on exercise to teach the participant to create and living, working care plan based on risk assessment.

### **Objectives:**

1. Discuss the necessary components to prove a pressure injury was unavoidable
2. Identify risk factors that place a resident at risk for pressure injury development and the correlating interventions that will minimize, stabilize, or eliminate those risk factors
3. Demonstrate how to properly utilize a risk and skin assessment in the development of the plan of care

### **Course Description:**

Accurate Assessment of a pressure injury is important as it evaluates the effectiveness of the overall course of treatment and determines the type of topical support needed. This course will provide the participant with the information needed to complete a comprehensive assessment of a pressure injury. This course will outline the NPUAP pressure injury staging system as well as wound measurement, wound base description, peri-wound, drainage, odor, tunneling, undermining and pain assessment. This course will also provide hands on practice.

### **Objectives:**

1. Describe etiologies of pressure injuries
2. Assess, describe, and document the physical characteristics of a pressure injury
3. Identify the appropriate stage of the pressure injury

2. Define effective topical treatment strategies for pressure injuries, utilizing the principles of moist wound healing
3. Discuss when debridement of pressure injuries is necessary and the different methods of wound debridement
4. Describe signs and symptoms of pressure injuries infection and treatment options

Many clinicians have difficulty differentiating lower extremity ulcers (arterial, venous, or neuropathy/diabetic) from pressure injuries. If a lower extremity ulcer is mistaken as a pressure injury it can lead to improper treatment of these areas and skew your pressure injury rates. This session will help clinicians differentiate arterial insufficient ulcers, venous stasis ulcers and peripheral neuropathic ulcers from pressure injuries when found on lower extremities and discuss how assessment and treatment strategies differ for each of these wound categories.

### **Course Objectives:**

1. Distinguish etiologies of lower extremity ulcers
2. Define the characteristics of venous, arterial, and peripheral neuropathy/diabetic ulcers
3. Describe effective strategies to manage lower extremity ulcers
