



# **PDPM: DEADLINE FAST APPROACHING**

## **PDPM ONE-DAY WORKSHOP AUGUST 21, 2019**

A new payment model for all SNF Medicare Part A payments takes effect on October 1, 2019. This new patient driving payment model (PDPM) completely transforms the way all Medicare Part A payments will be determined for SNFs.
